Finance and Personnel Committee

Trustee Leicht reported on the Finance and Personnel Committee meeting held on December 20, 2016. The purpose of the meeting was to receive a report from Public Works Director Scott Halbrucker regarding truck equipment and garage issues with possible recommendations to the Village Board regarding solutions. Mr. Halbrucker informed the Committee of several vehicle, equipment, and structural issues within the Public Works Department. The 1996, orange Ford tandem purchased many years ago from La Crosse County has significant mechanical issues. The muffler on the truck is not repairable, and he has been informed businesses cannot legally replace the muffler with the same type on this truck. A new muffler could cost \$5,000. There is a bad switch on the vehicle that no one can seem to locate, and if it is not turned off, the battery is drained. There is a large hole in the major brace for the wing, and it is rusted through. Mr. Halbrucker stated the truck was never designed to clear municipal streets. The 1994 Ford tandem has over 500,000 miles on it, and it also has several mechanical issues. Mr. Halbrucker stated there are tandem trucks available, but the plows do not turn on the trucks he has located so far. He believes he can find a used, replacement tandem for \$30,000 to \$50,000. Mr. Halbrucker then reported one of the 20-foot wide garage doors at the Village Shop needs to be replaced. The garage doors are 35 years old, weigh over 1,000 pounds, and the

nonfunctioning door is now a major safety concern and all repair options have been exhausted. The doors must be closed so that the sewer vacuum truck and other equipment do not become damaged due to the cold temperatures. If a new door is authorized, it will take at least four weeks before it arrives and can be installed. The Committee directed Mr. Halbrucker to locate a single-axle truck with a wing, plow, and sander now in order to continue this winter's snow clearing activities and continue searching for a tandem truck to replace the present one. He was also directed to order a new 20-foot wide garage door as soon as possible.

Motion by Trustee Leicht, seconded by Trustee Schumacher to approve the minutes of the December 20, 2016, Finance and Personnel Committee meeting. Roll call vote: Unanimous aye.

Motion by Trustee Leicht, seconded by Trustee Deal to adjourn the meeting at 7:30 p.m. Approved by voice vote.
