West Salem Tax Incremental Finance District #1 Status

Attorney Klos explained the present status and aspects of Tax Incremental Finance District #1. The TIF presently has \$1,406,808 of debt, and the tax increment collected of approximately \$177,000 is paid annually to La Crosse County toward this debt. Assuming there is no more development in the Lakeview Business Park, the TIF will be paid off one year before the TIF ends in 2027. At this point, the TIF is paying for itself. The County has the ability to add more costs to the TIF for the next five years, and it is important to ensure there is enough increment coming in to pay for any additional costs incurred. Any debt that is not paid off by the end of the TIF will be the responsibility of the Village of West Salem.
