Ordinance No. 445

Motion by Trustee Leicht, seconded by Trustee Schumacher to approve Ordinance No. 445 to Amend Wisconsin Administrative Code Section References in West Salem Code of Ordinances Chapter 9 Water and Waterworks. Roll call vote: Unanimous aye.

<u>Utilities Committee</u>

Trustee Schumacher reported on the Utilities Committee meeting of May 14, 2012. The purpose of the meeting was to review for recommendation to the Village Board a utility extension route and cost estimates for Rustic Road Village development on East Jefferson Street. Attorney Klos informed the Committee Rustic Road Village states they have discussed the updated estimates of costs to extend and install water and sewer utilities to their planned development on East Jefferson Street, and the developer has decided to go forward with the project contingent on award of a community development block grant. Cost estimates for the project include \$275,000 for extending water and

sanitary sewer from East Jefferson Street and \$58,750 for engineer costs for design, grant application and administration, bidding, and construction oversight. Installing water and sewer utilities on the East Jefferson Street route is cost effective, but no further extension to the east could be made without a lift station at an estimated cost of \$200,000. Engineer Dave Sauer has recommended extension of sanitary sewer from Industrial Drive which would serve further developments to the east without the cost of a lift station. The additional estimated cost of extending sanitary sewer from Industrial Drive is \$50,000, making the total estimated cost of the utility extensions \$372,987. This is a better option for the Village, and additional costs can be collected in the future through special assessments on future connections. Attorney Klos has been in communication with Sprint property owner Capstone, LLC, and obtaining an easement on the east side of this property does not seem to be a problem. Extending sanitary sewer under the DNR property and the railroad property is a simple permitting process, and Mr. Sauer has already had positive discussions with the two entities. Rustic Road Village development has set out three steps for discussion with the Village. It is important to Rustic Road Village that water and sewer lines are operational in time for an October 2012 opening. Ideally, they would like infrastructure to be in place by September 2012. Their understanding is the Village will be the applicant and recipient for an community development block grant, and they have requested the Village keep them informed of any licenses, agreements, or permits required to proceed with their development. The Committee discussed the fact the community development block grant will be awarded based on the number of new jobs created by Rustic Road Village. The Village should require Rustic Road Village to indemnify the Village on the jobs creation portion of the grant funding, and the Village should require a letter of credit from Rustic Road Village. The Committee recommended that West Salem agree to pay the additional estimated costs of \$50,000 to extend sanitary sewer from Industrial Drive based on the revised total cost estimate of \$372,987, developer Rustic Road Village will be responsible for all costs above the \$50,000 estimate, and the Village will work with developer in the grant application process and toward its goal of having the utilities in place in time for a October 2012 opening.

Motion by Trustee Schumacher, seconded by Trustee Leicht to approve the Utilities Committee meeting minutes of May 14, 2012. Roll call vote: Unanimous aye.

Motion by Trustee Lautz, seconded by Trustee Koelbl that West Salem agree to pay the additional estimated costs of \$50,000 to extend sanitary sewer from Industrial Drive based on the revised total cost estimate of \$372,987, developer Rustic Road Village will be responsible for all costs above the \$50,000 estimate, and the Village will work with developer in the grant application process and toward its goal of having the utilities in place in time for a October 2012 opening. Roll call vote: Unanimous aye.
