### South Mill Street Sidewalk Installation

Dean Olson of Yaggy Colby Associates presented a sidewalk plan for South Mill Street. Mr. Olson proposed the sidewalk be placed one foot off the right of way line on the east side of South Mill Street and five feet off the right of way line on the west side. Mr. Olson cited present power pole placements, the driveway for the lot on the southwest corner of Jefferson and Mill Street, and elevations. There is also an option for retaining walls, but the Village would have to obtain easements to do this. Three trees are also in or near the right-of-way.

Motion by Trustee Hoffman, seconded by Trustee Engel to go forward with the sidewalk installation on both sides of South Mill Street and refer the matter to the Planning Commission to get the project kicked off. Roll call vote: Unanimous aye.
