#### Ordinance No. 409 – Adult-Oriented Establishments

Village legal counsel has not completed review of Ordinance No. 409, and the Board agreed to put this Ordinance on the December 19, 2006, Village Board agenda.

## Ordinance No. 410 - Changes in Conditional Uses

Village legal counsel has not completed review of Ordinance No. 410, and the Board agreed to put this Ordinance on the December 19, 2006, Village Board agenda. Trustee Hanson would like the Board to consider eliminating the references to "caretaker", "sanitary landfill", "slaughter houses and rendering works", and "supervisor's dwelling unit" from the listed Industrial District conditional uses. In addition, Trustee Hanson felt "fur farms", "kennels", and "other Agricultural uses that may cause noxious odors or noise" also be eliminated from the listed Agricultural District conditional uses.

# Request from Unser Wide Track to Utilize Village Streets for Trucking

Jerry Unser is purchasing up to 100,000 cubic yards of dredge material from La Crosse County. Two specifications listed in the agreement for the sale of dredge material are:

1) All trucking shall enter and exit the County's farm onto East Garland Street, left on County Road C, and out of the Village of West Salem to Interstate 90; and 2) Trucking through the Village of Salem will not be permitted at any time without written approval from the Village of West Salem. Jerry Unser appeared before the Board to request written permission from the Village to utilize Village streets for trucking the dredge materials to his stockpile on Commerce Street. Mr. Unser stated that Trustee Hanson wrote a threatening note to Mr. Unser and placed said note on his truck. Trustee Hanson rebutted this accusation and requested Mr. Unser submit the threatening note to the West Salem Police Chief. The Board took no action on Mr. Unser's request as his work was to be completed on Wednesday, December 6.
